1.0 Introduction

Development of the second economy is the solution to the high rate of unemployment with emphasis on an integrated approach of maximizing and complimenting grants and initiatives of the different spheres of government, and cooperation of the private sector through cooperatives and business forums. KASI is Nxa is a job creation strategy that is aimed at creating jobs in KASI and it serves as a vehicle to implement Masilonyana Local Municipalities Economic Strategy. KASI is a local term that refers to the township. KASI is Nxa means that jobs must be created in KASI by KASI people in order to redress the economic challenges of the past. This also means that production of goods where possible must be done in rural areas and a market must be created in KASI for these products. This will also come up with a rural retention strategy. KASI has certain cultural and practices and the work of this document is to enhance those practices and ensure that KASI money remains in the hands of KASI people. This program has the ability to produce lots of jobs. One also wants to acknowledge that different sphere of government are having different Local Economic development programs in different town, which can have a greater impact when managed integratedly. It is also important to acknowledge and integrate the roles that must be played by mines i.e the mining charter. IN-DEPTH LOOK ON THE SECTOR'S ROLES WITH IN THE COLLECTIVE

2.2.1 The Food Society

It is a common practice that KASI people come together once a month and contribute a specific amount of money per month. They fund raise to increase their contributions. At the end of the year they use this money to buy in bulk groceries and this money is equally shared among people of the food society. This means throughout the year they have surplus amount of money that could have being invested in a one of the other sectors. These fund can be used in the tuck-shop cooperative and will increase the dividends of the Food Society cooperative but it will also ensure that groceries in the tuck-shops become affordable.

2.2.2 Tuck Shops

Tuck-shops were once the corner-stones of economical activities in KASI. This concept inspired the first economy to move away from chain stores, and rather concentrated on smaller shops like Spar, Friendly store etc. This concept of tuck-shops also inspired foreign entrepreneurs to take over tuck-shops. The main reason why tuck-shops are not successful is because our people are using individual buying power. This causes them to face the hardship of these sectors challengers as individuals. The new approach should be that the ownership of the tuck-shops should rest with the owner but its management should be centralized. This will assist this sector in removing the middle- man, improving the management, improving the technology, etc. The empty warehouses on the N8 will be used as warehouses and this will boost job creation.

2.2.3 Mobile and Street Corner Hawkers

It was shocking to lean that 60% of South Africa`s potatoes are actually sold by Hawkers. This is a market with incredible potential. There are 2 different type of hawkers i.e. Mobile Hawkers and Street hawkers.

It is also important to acknowledge that there are different types of hawking in Masilonyana Local Municipality i.e.

- Vegetable hawking
- Jewelry hawking
- Food Hawking
- Cloths hawking
- Car oil, Glue etc hawking

All these different hawking have enormous job creation potential if it is properly coordinated. This will be unpacked later in the document

2.2.4 Agricultural (Feedlots for Intensive Animal Production And Crop Production)

This is one of the most under-utilized sectors that governments award the greatest amount of financial assistance and it is least monitored. This document will attempt later to show the incredible potential that is in this sector. The key subsections in Agriculture are:-

2.3 Building Maintenance and Manufacturing Sector

This sector will adhere to strict levels of professionalism through provision and production of good quality material,

There will be various qualified professionals in all areas of construction and building maintenance; this professionals will be on call consulting specialists ready to provide services as required by the client.

This sector deals with all aspects of technical services and production of building and upgrading material such as paving bricks and wood-work / carpentry as well as fitting and turning, steel-works / welding, this services will be on call.

2.3.1 Building And Maintenance. (Builders; Painters; Plumbers and Electricians)

In every street in KASI there are more than 3 houses that are renovated or build. There is a lot of economical activity around this sector. The challenge in this sector is always to find a phone number that you can call to get a good Builders; Painters; Plumbers and Electricians. The second challenge is also that these entrepreneurs had no medium in which they could advertise and market their services. Through the Business center that Masilonyana Local Municipality will be implementing, will make it possible to bring the community and these entrepreneurs together

2.3.2 Steel-works. (General Welding And Steel Works)

This also has a brick manufacturing component that must be formalized, and properly located and marketed in MLM region. The University of Free State is willing to assist these entrepreneurs' bricks to become SABS approved

2.4 General Cleaning Services Sector

This sector is based on all cleaning services, in which both public and private sectors will be provided with cleaning services as required by the deserving client.

Services includes among others, Offices Cleaning (Corporate Services), Domestic Cleaning Services (House-hold cleaning), Gardening Services both for home owners and Businesses and the public sector.

Most of all this services will be on call services, in which clients will be linked and provided with the cleaning specialist's for that specific service needed.

Car-wash business or industry will be at the center of development and formalization in this sector.

2. 4.1 Gardening.

Throughout KASI there is a need for gardening service in a more KASI way. Each ward must have certain no of people that are carrying wheelbarrows and rendering a service. These workers will be contacted through Business center and will be dispatched to where their services are needed. This Gardening service will also be used by MLM in the cleaning of cemeteries, streets etc.

2.4.2 General Household Cleaning.

Throughout KASI there is a need for General household cleaning service in a more KASI way. Each ward must have certain number of people that are carrying detergent and rendering a service. These walkers will be contacted through Business center a team will then be dispatched to where their services are needed.

2.4.3 Car-wash at Location And Mobile car wash

There is a continued demand for car washes. More and more people are buying cars in KASI. There is a need for government to compliment initiatives of the communities. Car wash area has the potential to become the economical hot spots if there is proper infrastructure. The formation of this sector will give this sector buying power and the removal of the middle man in the buying of cleaning detergents.

Mobile car wash; Many people would love to see their cars washed without the efforts of going to the car wash. A unit will be dispatched per ward to go and wash the car in the privacy of the car owner's house for a little extra rands. The Business center could also play an important role in this coordination.

Deep cleaning services

This will be a special car wash place that will clean engines, upholstery and the interior of cars.

2.4.4 Corporate Cleaning Services. (Public And Private Sectors).

This is sector that will clean government and private sector building

2.5 Safety And Security

This sector is based on all safety and security services, in which both public and private sectors will be provided with those services as required by the deserving client.

Services includes among others, Offices (Corporate Security Services), Domestic Security and Safety Services (Child-care services, provision of "Nanny's) and House-hold protection, Personal Security and Safety Services both for home owners and Businesses and the public sector.

Most of all this services will be on call services, in which clients will be linked and provided with the cleaning specialist's for that specific service needed.

This sector will also be the guardians of this cooperative, they will oversee all aspects of safety and usage of all products and services provided by the cooperative.

2.5.1 Corporate Security Services. (Public And Private Sectors).

KASI security needs a KASI security solution in order to deal with the issue of crime. On daily basis there are capable men and women r

In these regular consultations, there will be information and logistics exchange and this process will be characterized by, integrated support and advice based strategy development.

4.0 The benefits

"KASI PEOPLE" will be the sole beneficiary of this program, and the benefits thereof are endless, we are looking at belonging to a structure that is extremely sustainable and has a collateral power to exist.

First of all employment is guaranteed for local unemployed people, in which they will be able to lead a normal life of self sustenance.

As for the existing local entrepreneurs, they will have better facilities and accessories with regard to car- wash business, hawking etc.

Local groceries store will be well stocked and never be out of stock, and provision support of chain management, through a system of a well coordinated software that is connected to the mainframe computer at the co-operative control office.

Training in areas of business management and finances as well as administration will be provided to members of the project.

This strategy/vehicle will further enhance the trading links between all Business Forum in the region.

Basic benefits will be offered to Business Forum members of this sector and that will be the prerogative of the Business Forum, in consultation with the towns' Business Forum

This program will also provide market control and create a niche since this program offers services and products that are "KASI" orientated and launched in areas where there is already existing business.

At last the business in townships will have the same tone of voice and exist as a unit, and this will give KASI businesses buying power, since they will be in a position to buy in bulk and be in position to negotiate purchase discounts. The market will be saturated by this process and this closes the market in our favor, since now it is common knowledge that most car sales are made by people living in "KASI".

5.0 Abstract

'KASI IS NXA is a vehicle designed to implement the Economic strategy and is a job creation program that deliberates to alleviate poverty and transform local economic development programs.

This is a regional community involvement program, whose objectives are to create employment in all sectors of business within the "Masilonyana Local municipality",

Community and public sector participation through "MLM`s KASI IS NXA Program" and "service providers" assistance in this life and economical altering program will create thousands of jobs for Masilonyana people.

This vehicle is based on all aspects of "KASI" businesses; we are referring to tuck shops; car washes; hawkers / mobile fruit and vegetables sales people.

The list is endless for this "KASI" orientated businesses, our objective is to take all this business sectors, join them together under one body, the "Business Forum" as the body of collective management that oversee all aspects of each activity of the structure.

The "MLM" role will be that of facilitating funding and growth ot the Business Forum and other private investors and the role of "Service provider" will be that of structuring; planning; implementation and monitoring progress of the Business Forum.

6.0 Initiative / what will be done

Implementation and mobilization of a well coordinated structure that will oversee all management of this Business Forum, the structure will have different levels of authority; obligations; responsibilities and accountability, and management thereof will be a line management system.

Below we have outlined a brief overview of this structure, and we will also highlight the importance of this particular structure, and exactly how will this structure function as a collective.

6.1 There will be mobilization of the following structures:

7.0 STRUCTURES OF KASI IS NXA

- 7.1 **Sectors** are the point of departure for the whole operation. They are ward based. This is a business classification strategy that groups businesses of the same industry or of the market in one integrity or entity referred to herein as a "**Sector**".
- 7.1.2 **Composition of sectors** in this regard is in relation to businesses that are currently existing in "KASI", such as tuck shops, car-washes, food and money societies, hawkers business, gardening, general maintenance, manufacturing and general cleaning services. These sectors will elect a fully representative body that will be the "Ward Business Forum".

7.2 Ward Sector Forum

These special level cooperatives are imperative to the growth and development of the whole structure, since it forms the foundation for the structural component of the business Forum. They are formed by bringing together a number of sectors in a specific ward in Masilonyana L.M. E.g Car washes, Brick layers etc.

7.3 Ward Business Forums

Each ward will have sectors. These sectors come together in a specific ward to form ward a ward sector. Different ward sectors come together to form a Ward Business Forum

7.4 TOWN Business Forum

This structure will be the second highest. The different Ward Business Forums comes together to form a Town Business Forum. Each of the towns of Masilonyana Local Municipality will have a town Business Forums. Town Business Forum will be formed out of members of the "ward Business Forums" and administration, this management structure will oversee all aspects of strategy development in / at town's levels.

7.5 Masilonyana Regional Business Forum

This is the epitome of this organization, a centralized station of executive decision making, Strategic and visionaries are structural components of this institution, since this will be regional structure capable of giving direction to the development of this structure, and also provide accurate comparative developments in all towns within the region.

8.0 Special Committees and Departments

To enhance and strengthen decisions taken by the "Regional Business Forum", there will also be the "Senior Admin Officer" providing executive advice in relation to all aspects of business administration.

This individual will be an extra pair of hands to the Business Forum at all levels, since there will be an Admin Officer from the cluster's levels throughout all levels of the Business Forum.

The Senior Admin Officer will be the head of the Administrative department. This individual will also form part of the Board of Directors on the Regional level.

Mobilization of this Business Forum and its constituency will be done over public consultations, and other relevant institutions and departments.

This session's will be interactive and each community will have the opportunity to gather in anticipation of this life altering experience, in which we will introduce the concept of "KASI IS NXA" to interested parties, and share visions about the future of this magnificent organization.

The reason behind this project is simple, we are reclaiming and relocating what is the public and business right of all KASI people, the process includes economic independence and viability for all KASI people.

This project will give employment to over thousands of people in the region and this means that there will be enhanced economic interaction of the people with the "HDI" status.

Fully and interactive economic activities of our "HDI's", will result in formalization of black owned businesses within the context of "KASI", and this will mean that we can easily be interactive members of the existing economy rather than creating a dual economy.

Controlled development is always the safest form of development since any aspect of collapse can be picked up in the early stages of the project and be dealt with in time.

This project offers control and collective management of projects, and allows for participation of all stakeholders in this project in a manner that is comprehensive and outlined strategically.

Coordination of this project is done prior implementation, and implementation is also managed strategically, by people who will be in the position to deal with such aspects of strategic management.

Members of this Business Forum will be capacitated in areas of training programs that are relevant to the needs of the Business Forum. We will also structure portfolios in / with regard to those specific needs of the organization and the individual members within each structure (sector; ward sector; ward Business Forum, town Business Forum and regional Business Forum)

Program Description

"Kasi is nxa", Is an economic redistribution program that deals with issues of business as community organizations, with the objective of redefining the way people do business in the context of township based businesses.

In this project we incorporate various project development and practical business approach in "Kasi".

There are "Business Sectors", in this project as they are arranged in such a way that they all form a structural part of the whole cooperative, we are referring to business of various sectors as explained herein.

Business Sectors includes services and manufacturing businesses as well as retail businesses, we have the following sectors in this project as key sectors that form the basis for this project.

9.0 Program Background

"Kasi is nxa", is a program that is rooted in the same fiber of community program as all previous community programs, this program emerges out of all but different reasons and approach.

This is a community initiative program, by this we mean that the approach towards this program will be inclusive of the all the Masilonyana communities, this will engage the communities in strategic development of this initiative.

This approach will determine the way this Business Forum will be run, this way time taken to develop an efficient strategy to run and enhance delivery through this Business Forum.

This will be administered as a community organization and managed as a business organization, whose objective will be to develop a business that has the potential to grow.

The Business Forum will engage all existing and new emergent "Kasi business" in a strategic and interactive campaign to redefine the way of doing business in our townships.

Formalization of these targeted businesses will further enhance the local economy, and this will result in profitable returns over a specific period, hence this Business Forum addresses issues of redirecting the local economy back in the hands of "Kasi People".

This Business Forum emanates also from the current trend that sees the local economy towards a transition stage that favors the foreign entrepreneurs to rip the benefits of "Kasi" economy and this situation cannot be allowed to prevail.

"Kasi is nxa" is a job creation strategy, with an objective of achieving the best possible results, as a result more entrepreneurs will be produced and our local economy will be improved.

This will be the new approach towards projects in our region and this will revolutionize the way of community projects, and will be the first of its kind. **Previous Projects along the Same Lines**

Taxi industry is one of the industries that under-goes the similar but, particular in objectives and strategy. "Kasi is nxa" is a Business Forum that has the same principle as the recapitalisation project, but totally different approach.

"KASI IS NXA" is a broad based Business Forum, in which all reputable township businesses will be formalized and benefits the public in general, both directly and indirectly, by means of participation of all stakeholders.

This project also addresses issues of job creation by establishing more and more businesses within the context of Kasi and not just necessarily only for those well established businesses or emergent ones.

Through this Business Forum more entrepreneurs will emerge as result of intensive training programs within this project.

9.1 Current Issues, Trends, and Problems This Business Forum Addresses

There have been a number of projects developed simply for the purpose of empowering our communities, in the context of "Historically Disadvantaged Communities", sadly more and more of these initiatives have collapsed due to a number of issues.

This state of affairs starts with agricultural projects and extends to social development projects, and the resultant thereof is still the sad one of evident mismanagement and poor planning as well as implementation.

Issues relating to the collapse of projects, extends to social dynamics of which this is the only convicted culprit, when as a matter of fact this is not just about the said dynamics, but there are also issues of logistics, capacity building, proper and sufficient support structures.

In relation to this issues, one needs to be aware of the sad reality of all regional and provincial departments as well as local government of the fact of this institutions short-comings especially in the context of integral participation of all the stake holders, especially the communities who are the targeted beneficiaries.

This situation renders facilitators of development as incompetent and inefficient in the eyes of the local communities.

Communities involved in projects, are susceptible to conflicting situations and most of this projects members are not capacitated to deal with issues of conflict resolution within the organization scope and as well as in the working environment context.

Most of project members are not equipped with the relevant skills and knowledge to handle the stressful business environment, these problems emanates from the root of planning, implementation and control in an environment that is not friendly for those that interacts in it.

In a nutshell programs are initiated with the right and measurable objectives, and this initiative is met with a lot of challenges and obstacles, than opportunities, and this does not favor development since it forces the projects members to concentrate on solving personal problems than developing strategies that will see these projects to a sustainable future.

10. Research Done On the Subject.

We have conducted research on various levels of social development projects, and much was revealed in all aspects role players in this life changing experiences and activities.

For the purpose of this project, we wish to concentrate on the impact of the environment on these projects; there are aspects of "**internal and external environment**" on the project and the project and the impact of the project on the same environment.

We have sufficient data to help us orientate the proposed project in the right direction and place within that particular environment, we also have the strategy to tailor make the objectives of this projects to help the project use the environment to the best of the projects beneficial ability.

The ability to assess the environment accurately will be one of the important capacity building programs in this Business Forum, this will help us and the project to coordinate and structure this project within the scope of project development, and we have also identified performance measurement strategies / system as one of the issues underlying the collapse of this project.

We intend using the research information in planning, strategy development, implementation and control for this project.

This program will merge all the informal businesses in the townships and this will bring them at sector levels as different industries.

These sectors will form a ward Business Forum within that particular town / region.

This initiation will be a sustainable activity, since it deals with all aspects of community development, and this is guaranteed by the fact that this project is based on current and sustainable businesses in "Kasi". **Example:**

Local economy in the context of township is gradually shifting towards the foreign entrepreneur and sadly there was nothing that could have been done, until today.

This sad reality was due to the fact that most people in Kasi who were in business did not have the right support structures if not at all, and this led to the collapse of Kasi economy, in the hands of the very same people who built it.

Information

Information with regard to this program was gathered from our research.

11.0 Benefits

This program will be the answer to the most critical question "of job creation", since it will offer more than thousands guaranteed jobs.

In addition to that, there will be thriving communities due to a healthy sustainable economy.

The issue of the lack of capacity building in areas of training programs, will be a thing of the past. Since this project offers training to members of the Business Forum.

There will be an entry level and exit level for willing individual who are confident enough to try it on their own, but strategy will be decided along other major decisions, this way capable entrepreneurs are produced.

There are a number of factors of development that are directly and indirectly connected to joblessness / unemployment, this are issues of concern like, POVERTY and Related Sickness, "HIV and AIDS", Increasing Levels Of Crime as well as ECONOMIC DEPENDENCY.

"A service Agent", that is a developmental consulting agency will be engaged in company / institutional commissioned research that deals or focuses on core issues underlying real issues the actual cause of collapse of development projects.

After much thought and deliberation with most of the stake holders "Communities", it has come to our attention that this project is generally receiving a warm welcome already, and we know that this will be exceeded by far at the time of the launch.

This Business Forum is receiving this form of support because of the potential of realistic objectives achievable within considerably reasonable time after final consultations with all stakeholders.

Structuring and Coordination of this project will be an interactive campaign that engages all the targeted role players, in specifics roles as determined by the interim structure / temporary Coordinated by a "Business Forum/Business Center".

13. Objectives

First Objectives

Coordinate and mobilize a business structure that will be sustainable and to create an organization that will give rise to efficient business man and woman in "KASI'

Approach / Strategy

Coordination of this structure will be done by means of public interactions, run through public gathering spaces at the beginning and later on move to different locations as per development.

Community radio stations will be used to introduce this brilliant project to the masses, since this will be an open invitation to the public for conclusive participation.

Mobilization of the masses will be completed in four weeks right after implementation, and then followed by coordinating a structure that will take all the decisions under guidance of the project coordinator "Business Forum".

After coordination of this powerful structure, there will be tailor made training program, designed to propel this group of energetic team towards a direction of leading this organization of change.

This group will then structure and develop a strategy that serves to drive this organization towards meeting its objectives, they will also set out policies running this organization and all logistical preparation of the Business Forum.

This organizational executive team will have three levels, from top to bottom. There will be the:

- Regional Business Forum
- Town Business Forum
- Ward Business Forum

These structures will also have the external administrator, this administrator is an element of stability at all levels of the cooperative and there will also be the council of administration officers that reports directly to the regional / senior administration officer.

Decisions of this body will always have the input's of this task team as a compulsory and binding strategy that strengthens all decisions taken.

Second objective

Reform and redefine business practices in "KASI". educate and redirect "KASI" entrepreneurs to be professional entrepreneurs and redirect the economy towards the "HDCs.

Approach / Strategy

Currently business in "Kasi" is undertaken through a system that is nonconventional and therefore the people in Kasi are not getting exactly what they deserve in business, this is due to the lack of knowledge of managing businesses.

This Business Forum undertakes to educate local entrepreneurs as well as emergent entrepreneurs in areas of business management and financial management.

Capacity building programs will be designed in such a way that they cater for people with the lowest education or even with no education at all.

Third objective

Eliminate poverty by means of an integrated job creation strategy and to establish an organization with the capacity of national expansion.

Approach / Strategy

This project deals with issues of socio-economic development, and that offers this Business Forum the opportunity to grow as much as it can by means of extensive and consultative networking.

Provincial expansion of this project is inevitable, and while on the other hand the potential to grow even further to the national levels depends entirely on the successes of this project.

National expansion of these programs depends also on the effective and good leadership qualities of the executive board of directors as well as mobilization of membership in those specific areas of development.

Coordination of this program gather's people within poverty stricken areas and those that are not, in one environment designed to eliminate poverty by means of job creation strategy, skills development is also paramount to this.

This way executive leadership the Business Forum and the management of the Business center will be in a position to monitor progress of each and every particular business within each and every sector in the region; towns and wards.

Struggling business will be picked up immediately and will be dealt with by means of a reactive support necessary to rid that particular business out of that unfavorable environment.

This strategy is also applicable to the ward; towns and even the region as an entity, overall progress will be monitored and this way any struggling town or even sector will be given that particular attention it needs to survive and prosper.

Pressure on the part of the region will be reduced as management will be direct and hands on, this allows the Business Forum to focus on growth.
