Tender documents are available at R350.00 non- refundable cash payment. Tenders must be enclosed in a sealed envelope clearly stating the tender number. All Prices quoted must be VAT inclusive, except in the case of non-VAT vendors. No tender document will be accepted if not properly sealed and marked, Certified copy of letter of good standing in respect of Workman's compensation (COIDA) must be submitted. Bidders are required to submit original and valid BBBEE status level verification certificate. A compulsory site briefing and site clarification will be held as stipulated above. Supply chain management policy of Masilonyana Local Municipality will be applied.

Bidders must comply with all terms and conditions as outlined in the bid document. Bids will be evaluated in terms of the preferential procurement policy framework act, 9010.Bids not signed by the bidder will be rejected, No rectification/correction fluid may be used on the document.
