The following conditions will apply:

The tender will be evaluated using 80/20 & 90/10 preference points system. A two stage evaluation process will be followed, i.e functionality and preference point system attached as schedule 2 in the tender document. Tender documents are available at R350.00 non-refundable cash payment. Tenders must be enclosed in a sealed envelope clearly stating the tender number. All Prices quoted must be VAT inclusive, except in the case of non-VAT vendors. No tender document will be accepted if not properly sealed and marked. Certified copy of letter of good standing in respect of Workman's compensation (COIDA) must be submitted. Bidders are required to submit original and valid BBEE status level verification certificate. A compulsory site briefing and site clarification will be held as stipulated above. Supply chain management policy of Masilonyana Local Municipality will be applied.

Bidders must comply with all terms and conditions as outlined in the bid document. Bids will be evaluated in terms of the preferential procurement policy framework act, 9010. Bids not signed by the bidder will be rejected, No rectification/correction fluid may be used on the document. Bids received after closing Time and/ DATE will NOT be considered. The highest points or any bid will not necessarily be accepted, and the Municipality reserves the right to sub-divide the contract and/accept any portion of any bid thereof, Masilonyana Local Municipality reserves the right not to make any appointment. Tenders must be delivered personally and be placed in the Masilonyana Local Municipality's tender box. No emailed or faxed tenders will be accepted. No bids will be considered from persons in the service of the state. There will be a compulsory briefing session, your tender will automatically be disqualified for non-attendance. Please note that should you not receive any correspondence from the municipality regarding your bid within three months after the closing date of this advertisement, you should regard your bid unsuccessful.
