REGISTRATION OF SUPPLIERS ON THE CENTRAL SUPPLIER DATABASE

In terms of regulation 14(1) of the Municipal Supply Chain Management Regulations, the accounting officer must keep a list of accredited prospective providers of goods and services and infrastructure procurement requirements of the municipality or municipal entity that must be used for the procurement requirement through written or verbal quotations and formal written price quotations and at least once a year through newspapers commonly circulating locally, website of the municipality or municipal entity and any other appropriate ways, to invite prospective providers of goods and services and infrastructure to apply for evaluation and listing as accredited prospective providers.


In line with this regulation and supply chain management reforms introduced by government, all prospective service providers of goods and services and infrastructure procurement are required to apply on **Central Supplier Database** in order to do business with all organs of state in the Republic of South Africa at <https://secured.csd.gov.za/>

The municipality further invites all prospective service providers within the jurisdiction of the Masilonyana Local Municipality who do not have the capacity to register on the Central Supplier Database to visit the municipal SCM Office: 58 Piet Retief, Theunissen, 9410: for assistance with registrations. Upon registration on the CSD, your company will be issued with a unique CSD number, which will be used as a reference and must be stated on all quotations and tenders as from 18 July 2016.

With effect from 01 August 2016, Masilonyana Local Municipality must use and verify suppliers registration on the CSD. Therefore, you are required to please register on the CSD before 29 July 2016.

Failure to register will result in Masilonyana Local Municipality not being able to conduct business with your company/ entity.
