

- The **80/20** preference points system will be used for this bid as indicated in the document (MBD6.1).
- Functionality scoring will be applicable to this tender.
- Proof of (CSD) Central Supplier Database Registration must accompany the bid document.
- Tax Compliance Status pin must be submitted.
- Latest and Valid Municipal Rates and Taxes that is not more than 90 days outstanding, and (in the case of a lease agreement, bidders must attach both lease agreement as well as the latest and valid municipal rates and taxes of the landlord that is not more than 90 days outstanding).
- No bid documents will be considered from a person in service of the state.
- Bids must be properly sealed clearly stating the tender reference number.
- The National Treasury general conditions of contract will be applicable to this tender.
- No correction fluid will be used on the document.
- Bids received after closing **TIME** and/ or **DATE** will **NOT** be considered.
